Each year, the progress of all students at BCCA is evaluated to determine their eligibility for re-registration. This application for re-registration indicates that the applicant is interested in re-enrolling for the 2025-2026 school year, should the applicant be eligible.

Please complete the following application and submit it to the office by **February 10<sup>th</sup>, 2025 along with a non-refundable re-enrollment Tuition deposit of \$2,830.** Applications and deposits received after this date will incur a re-registration fee of **\$500 (per family).** As space is very limited, this will secure your position for the 2025-2026 school year.

By March 31<sup>st</sup>, 2025, the balance of \$20,000.00 (refer to table for siblings' rates) must be paid in full along with the appropriate student fee and medical insurance fees. (See reverse side for the student activity and other fees). \_If full tuition is not received by this date, the student's position will not be held and the \$2,830 will not be refundable.
